Subject: Study on 'The role and impact of research organisations participation in the Framework Programmes'

The European Commission Directorate-General for Research and Innovation (DG RTD) has commissioned Ernst&Young in consortium with Open Evidence and Technopolis Group as subcontractor, to carry out a study on the role and impact of research organisations participation in the Framework Programmes. The study is intended to explore the short and long-term scientific outcomes and impacts resulting from the participation of RTOs in the FPs. The study will shed light on the extent to which the FPs have encouraged the emergence of new trends in the evolution of the RTOs in Europe. In particular, the study will examine the impact of the FPs in improving the functioning of RTOs and in strengthening their competitiveness at both European and global level. It will also analyse the role of RTOs in the development of the FPs and EU research and innovation policy.

The results of the study will help in further understanding the effectiveness and efficiency of the Framework Programmes as well as in the design of new programmes. They will also be an input to the work of the FP7 ex post evaluation Expert Group.

The study foresees a series of interviews and case studies at the level of individual RTOs to obtain in-depth information on the pattern participation, on scientific output and impacts, on impact of FPs on different dynamics and evolutions of RTOs, on the contribution of RTOs to the development of FPs and the EU research policy.
